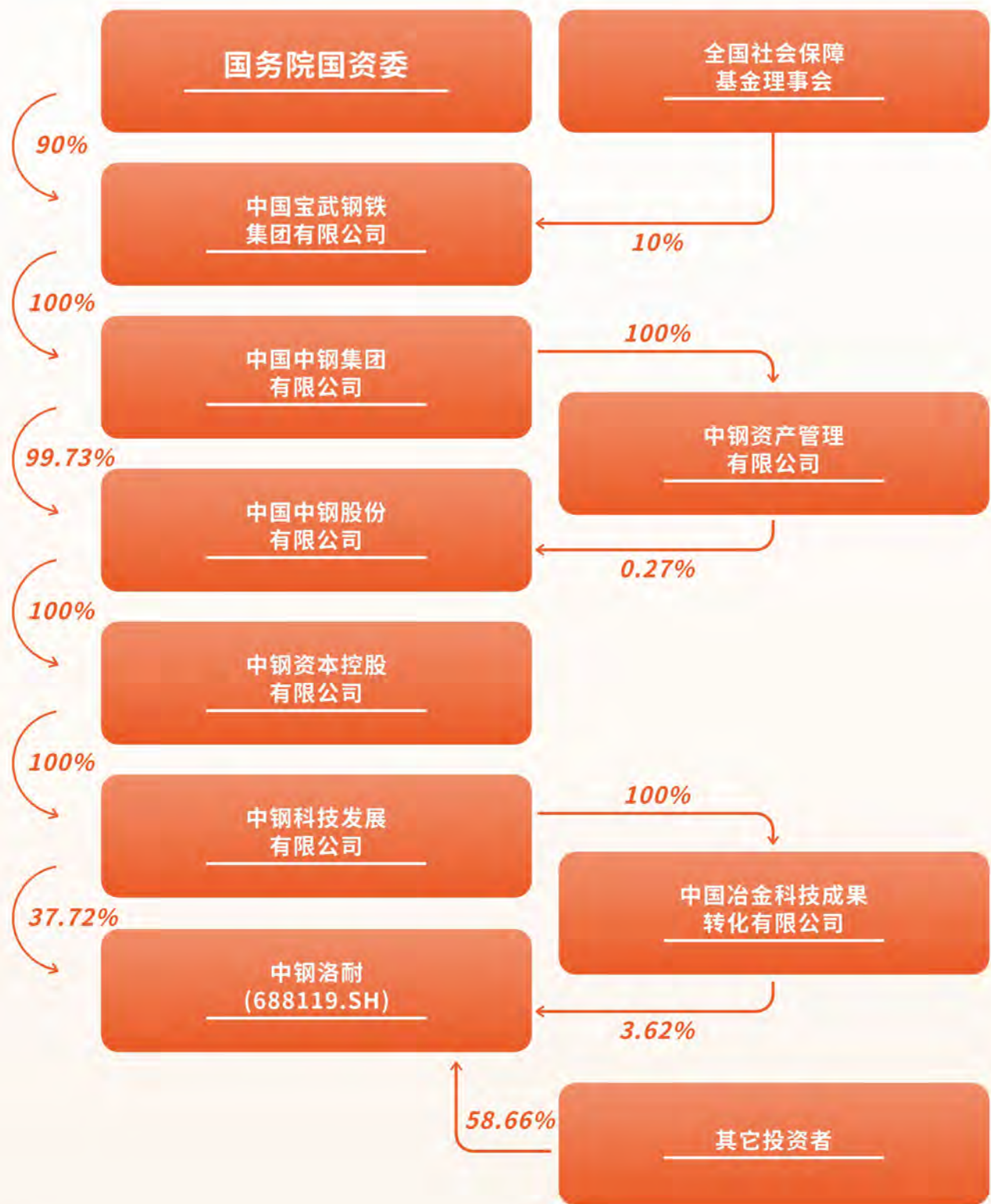

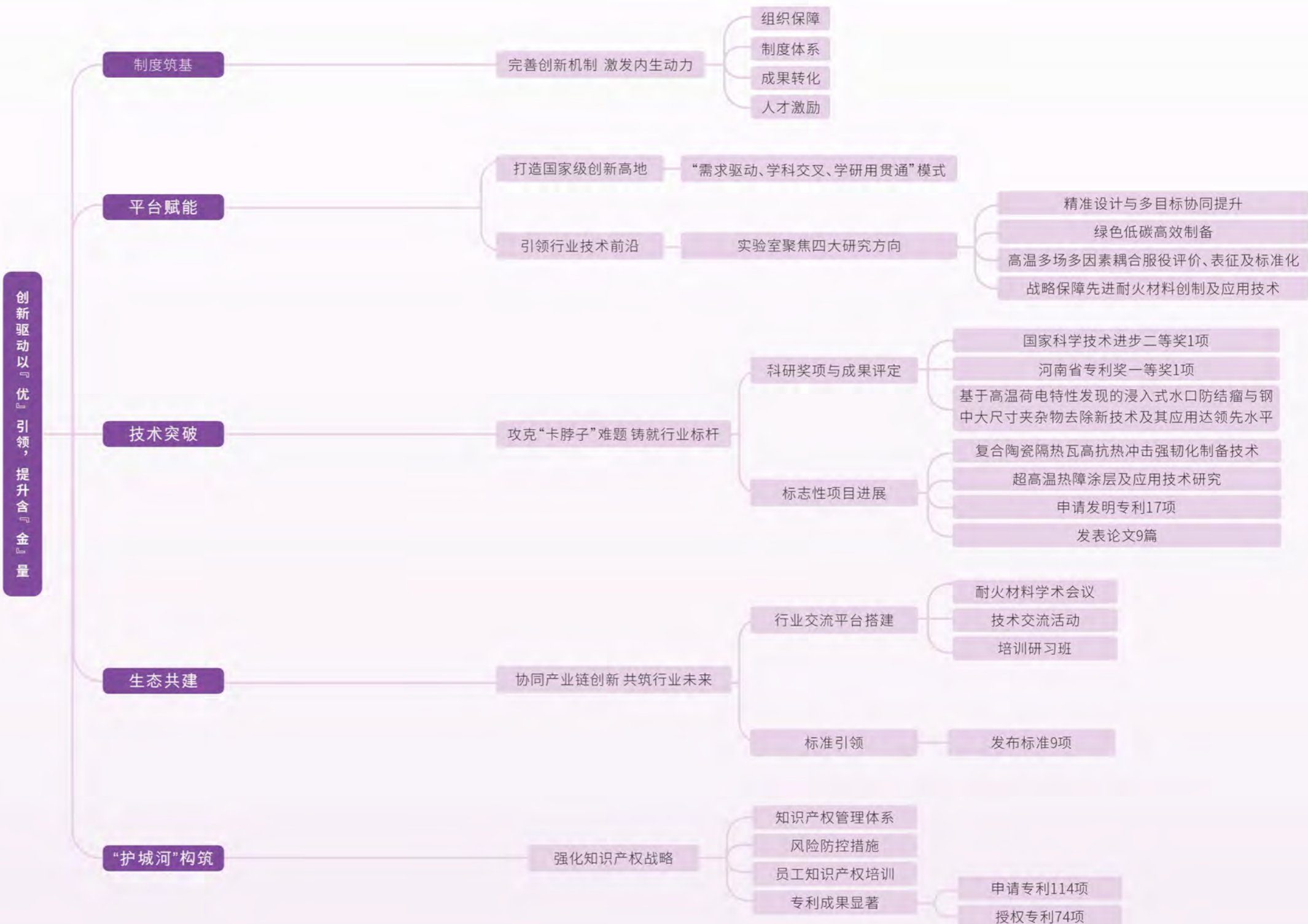

创新是引领发展的第一动力，更是企业实现可持续发展的核心引擎。2024年，公司研发投入总额**12646.29万元**，为技术创新提供了强劲动力。作为中国耐火材料行业的领军企业，中钢洛耐始终将创新作为企业发展的战略支点，以制度保障为基石、以平台建设为依托、以技术突破为目标、以协同合作为纽带，构建起覆盖基础研究、技术研发、成果转化、产业协同的全链条创新生态。本专题聚焦中钢洛耐在2024年以创新为核心的责任实践，系统呈现公司在技术创新、研发投入、知识产权保护、产业链协同及标准引领等方面的突出成果，展现其对行业高质量发展与绿色低碳转型的引领作用。

Innovation is the primary driving force for development and, more significantly, the core engine for enterprises to achieve sustainable development. In 2024, the company invested a total of CNY 126.4629 million in research and development, providing a powerful impetus for technological innovation. As a leading enterprise in China's refractory materials industry, Sinosteel Luonai Co., Ltd. has always regarded innovation as a strategic pivot for corporate development. With institutional safeguards as the cornerstone, platform construction as the foundation, technological breakthroughs as the goal, and collaborative cooperation as the link, it has established a full-chain innovation ecosystem covering basic research, technological research and development, achievement transformation, and industrial collaboration. This special topic focuses on Sinosteel Luonai's innovation-centered responsibility practices in 2024, systematically presenting the company's outstanding achievements in technological innovation, R&D investment, intellectual property protection, industrial chain collaboration, and standard leadership, and demonstrating its leading role in the high-quality development and green and low-carbon transformation of the industry.



## 完善创新机制 激发内生动力

### Improving the innovation mechanism and stimulating internal driving forces

中钢洛耐通过系统性制度建设,明确了技术创新的重点方向与任务,为激发全员创新活力,公司构建了“四位一体”的科技创新激励机制。

Through systematic institutional construction, Sinosteel Luonai has clarified the key directions and tasks of technological innovation. To stimulate the innovation vitality of all employees, the company has established a "four-in-one" scientific and technological innovation incentive mechanism.



出台《科研项目管理办法》《揭榜挂帅项目管理办法》等制度,建立“目标导向、权责明确、动态考核”的科研管理体系;通过《专利管理办法》《科技创新奖励管理办法》等,打通“研发—转化—激励”闭环。

Formulate and issue regulations such as the "Administrative Measures for Scientific Research Projects" and the "Administrative Measures for Projects under the Taking up the Challenge Mechanism", and establish a scientific research management system featuring "target-oriented approach, clear rights and responsibilities, and dynamic assessment". Through systems like the "Patent Management Measures" and the "Measures for the Management of Scientific and Technological Innovation Incentives", the closed loop of "research and development-transformation-incentive" has been established.



设立专项基金支持科技成果产业化,报告期内推动12项技术成果转化为新产品、新工艺,其中“基于高温荷电特性发现的浸入式水口防结瘤与钢中大尺寸夹杂物去除新技术及其应用”实现规模化应用,助力钢铁企业降本增效。

Special funds have been set up to support the industrialization of scientific and technological achievements. During the reporting period, 12 technological achievements have been promoted to be transformed into new products and new processes. The laboratory focuses on four research directions.

The “New Technology for Preventing Clogging of Immersion Nozzles and Removing large-sized Inclusions in Steel Based on the Characteristics of High-temperature Electrical Charge and Its Application” was evaluated by the Chinese Society for Metals as reaching the international leading level.

National Key Research and Development Program “Preparation Technology for High Thermal Shock Resistance, Strengthening and Toughening of Composite Ceramic Insulation Tiles”: by employing cross-scale gradation of raw materials (from millimeter to micrometer scale), interface design and pore regulation, a new generation of toughened ceramic insulation tiles with the characteristics of “increasing strain tolerance and enhancing stress relief ability” has been developed. The Special Project of Henan Province Guided by Central Government for Local Scientific and Technological Development, “Research on Ultra-high Temperature Thermal Barrier Coatings and Application Technology”, has broken through the technology for batch and stable preparation of high-purity rare earth tantalate spraying powder, completed the research on the structural design and spraying process optimization of rare earth tantalate thermal barrier coatings, and innovatively developed a YSZ/tantalate/nano-composite coating with excellent comprehensive performance. Through the implementation of the project, 17 invention patents were applied for, and 9 papers were published, including 7 papers included in SCI and 1 paper included in EI. Currently, the project has successfully passed the acceptance inspection.

公司根据国资监管和上市公司监管体系的相关要求,修订完善《关联交易管理制度》《募集资金管理制度》《信息披露管理制度》等10项基本管理制度,并制定了《独立董事专门会议工作制度》,为公司规范治理、高效决策提供了完善的制度依据;2024年,公司召开董事会13次,审计委员会4次,起草拟定了21项议案,召开薪酬与考核委员会3次,战略委员会、提名委员会各1次,审议了《公司2023年度财务决算报告》《关于公司高级管理人员2023年度报酬情况的议案》《关于提名公司第二届董事会补选非独立董事候选人的议案》及《关于公司〈2023年度环境、社会及治理(ESG)报告〉的议案》等。

In accordance with the relevant requirements of the state-owned assets supervision system and the supervision system for listed companies, the company has revised and improved 10 basic management systems, including the "Related Party Transactions Management System", the "Raised Funds Management System" and the "Information Disclosure Management System", and formulated the "Working System for Special Meetings of Independent Directors", providing a sound institutional basis for the company's standardized governance and efficient decision-making. In 2024, the company held 13 board of directors meetings and 4 audit committee meetings, and drafted and formulated 21 proposals. The Remuneration and Appraisal Committee held 3 meetings, the Strategy Committee and the Nomination Committee each held 1 meeting. The company deliberated on the "Company's 2023 Annual Financial Final Accounts Report", the "Proposal on the Remuneration of the Company's Senior Management in 2023", the "Proposal on Nominating Candidates for the Supplementary Election of Non-independent Directors of the Company's Second Board of Directors", the "Proposal on the Company's <2023 Annual Environmental, Social and Governance (ESG) Report>", etc.

## 董事会构成多元化

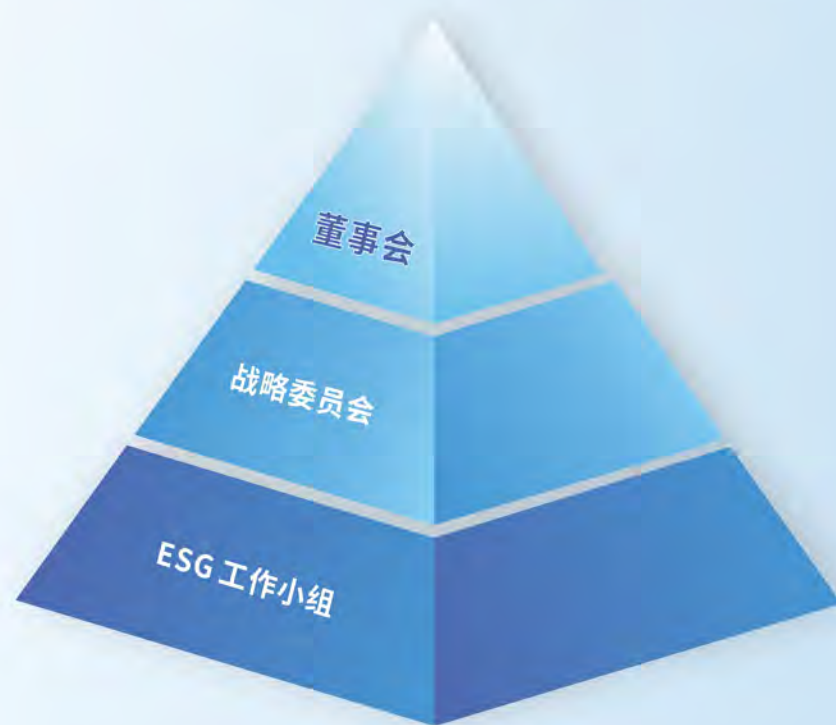
The company's Board of Directors is composed of 7 directors, among which 5 are external directors, and 3 of them are independent directors. The number of independent directors exceeds one-third of the total number of directors on the Board. There is 1 female director, accounting for one-seventh of the total number of directors on the Board. The composition of the Board of Directors complies with the requirements of relevant laws, regulations and regulatory documents. Two directors are management personnel at the company's operational level, and two are dispatched or recommended by the company's shareholders. The composition structure of the company's Board of Directors can fully exert the fair and just role of the Board in decision-making. The members of the Board of Directors include professionals in fields such as refractory materials, accounting, law and management, etc., enabling the full utilization of the professional expertise of the Board members in various fields. During the reporting period, the company held a total of 4 general meetings of shareholders, 13 meetings of the Board of Directors and 6 meetings of the Board of Supervisors. The procedures for convening and holding these meetings, the qualifications of the attendees, the voting procedures of the meetings, the voting results and the contents of the resolutions are all legal and compliant. The meeting materials are complete and in order, and the company has fulfilled its information disclosure obligations in a timely manner in accordance with relevant regulations.

As a specialized research and deliberative body for ESG affairs, the Strategic Committee of the Board of Directors studies the ESG report formed by the company and puts forward suggestions. The ESG report, after being reviewed and approved by the Strategic Committee, is submitted to the board of directors for review. Only after passing the review can it be disclosed externally.

The Strategic Committee is composed of the company's chairman and 2 independent directors, and the chairman serves as the chairperson of the Strategic Committee.

The company attaches great importance to the protection of intellectual property rights. In accordance with relevant laws and regulations such as the Patent Law of the People's Republic of China and the Enterprise Intellectual Property Management Specification, it has established and improved the intellectual property protection and internal management systems, standardized the risk control procedures, implemented dynamic ledger management for all the intellectual property work of the company, and regularly evaluated the market value, economic value, technical value and potential risks of the obtained intellectual property rights. At the same time, it pays attention to the protection of the legitimate rights and interests of various intellectual property rights of the company, strengthens the market monitoring of intellectual property rights, tracks and investigates relevant intellectual property infringement and infringed behaviors, and prevents the core technologies from being maliciously stolen or lost. By introducing the big data intelligent analysis and management system of intellectual property rights, it ensures the effective sharing of information on the resource platform.

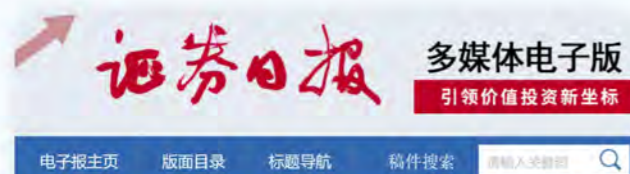

公司认真贯彻落实数据安全与隐私保护相关法律法规要求，健全数据管理体系，按照相关法律法规要求和上级公司数据安全定级指南，开展重要数据和核心数据识别工作，完成公司数据安全分类分级保护。建立全方位、多层次的安全机制，健全数据管理体系：通过数据加密防止数据窃取或被轻易解读；部署综合防护技术体系，及时发现并阻止恶意攻击；建立数据安全管理制度，明确人员职责和权限；定期开展分级安全培训，提升全员安全素养与意识；配置数据治理岗位，开发数据产品和服务，充分发挥数据要素价值，驱动公司数字化转型和智能化提升。数据机房配备精密空调、UPS、动环系统、自动数据备份设备；办公网络部署网络防火墙、入侵检测、态势感知等安全设备，具备身份鉴别、访问控制和系统审计，能有效防御网络攻击，保障数据与隐私安全。

The company earnestly implements the requirements of relevant laws and regulations on data security and privacy protection, improves the data management system, carries out the identification work of important data and core data in accordance with the requirements of relevant laws and regulations and the data security classification guidelines of superior companies, and completes the classified and graded protection of the company's data security. It establishes an all-round and multi-level security mechanism and improves the data management system: preventing data from being stolen or easily interpreted through data encryption; deploying a comprehensive protection technology system to promptly detect and block malicious attacks; establishing a data security management system to clarify the responsibilities and authorities of personnel; regularly conducting graded security training to improve the security literacy and awareness of all employees; configuring data governance positions, developing data products and services, giving full play to the value of data elements, and driving the company's digital transformation and intelligent improvement. The data computer room is equipped with precision air conditioners, UPS, dynamic environment monitoring systems, automatic data backup equipment. The office network is equipped with security devices such as network firewalls, intrusion detection, and situation awareness, which have functions of identity authentication, access control and system auditing, effectively defending against network attacks and ensuring data and privacy security.



## 健全监督体系 防范各类风险

### Improving the supervision system and prevent all kinds of risks

公司严格贯彻落实中国宝武《关于落实廉洁风险防控工作的实施意见》，全面排查本企业重点领域、重要流程、关键环节存在的廉洁风险，坚持求真务实，真抓严管，以“人财物”管理的权力运行和监督制约为核心，以加强廉洁风险和管理风险管控为目的，在元旦春节、五一端午、中秋国庆等重大节日期间，通过发送提醒短信、微信等方式开展警示教育；为进一步加强廉洁风险防控，公司发布了《关于落实廉洁风险防控工作的实施意见》等制度，并加强学习宣贯，通过完善相关管理制度和业务流程，构建覆盖职能运行全过程的风险管控机制。

The company strictly implements the "Implementation Opinions on Implementing the Prevention and Control of Cleanliness Risks" of China Baowu, comprehensively investigates the cleanliness risks existing in the key areas, important processes and key links of the enterprise. Adhering to the principles of seeking truth from facts, earnestly implementing and strictly managing, with the operation, supervision and restriction of the power in the management of "personnel, property and materials" as the core, and aiming at strengthening the prevention and control of cleanliness risks and management risks, during major festivals such as New Year's Day and Spring Festival, Labor Day and Dragon Boat Festival, Mid-Autumn Festival and National Day, the company conducts warning education through sending reminder text messages, WeChat messages and other means. To further strengthen the prevention and control of cleanliness risks, the company has issued the "Implementation Opinions on Implementing the Prevention and Control of Cleanliness Risks" and other systems, and strengthened the study, publicity and implementation. By improving relevant management systems and business processes, a risk control mechanism covering the whole process of functional operation has been established.



报告期内,公司及下属子公司相关管理人员参加国资央企大讲堂,参加新公司法、涉外法治系列课程培训;公司各单位员工参加河南省工会劳动法律监督员网络培训、合同风险管理培训、能源环保培训等各类型法律及行为合规管理培训,加强公司法治与合规文化建设,在企业内部营造依法合规的良好氛围,让依法合规经营成为全体员工的自觉行为,牢固树立底线思维和红线意识。2024年度公司参培人数共计6303人次,总学时合计53272.5时长。

During the reporting period, the relevant management personnel of the company and its subsidiaries participated in the lecture hall for state-owned assets and central enterprises, and participated in the training of a series of courses on the new Company Law and foreign-related laws. The employees of the various units of the company participated in various types of legal and compliance management training, such as the online training for labor law supervisors of the Henan Provincial Federation of Trade Unions, contract risk management training, and energy and environmental protection training to strengthen the construction of the company's legal and compliance culture, create a good atmosphere of legal compliance within the enterprise, make the compliant operation a conscious behavior of all employees, and firmly establish the bottom-line thinking and the awareness of the red line. In 2024, the total number of participants in the company's training was 6,303, and the total class hours were 53,272.5.



优化依法治理体系,公司建立统一领导、分级负责的合规管理体系,设立法治建设与合规管理委员会,实行总法律顾问制度,围绕生产经营与改革发展,持续推进依法治企和合规运营管理体系建设,明确各治理主体决策权责;严格规范信息披露,防范内幕交易;完善工作机制,构建协同运作机制,提升管理效能。

To optimize the legal governance system, the company has established a compliance management system with unified leadership and hierarchical responsibility, set up a Committee for the Legal Construction and Compliance Management, and implemented the system of chief legal counsel. Focusing on production, operation, reform and development, it continuously promotes the construction of the management system for legal enterprise management and compliant operation, and clarifies the decision-making rights and responsibilities of each governance subject. It strictly standardizes information disclosure to prevent insider trading. It improves the working mechanism, establishes a coordinated operation mechanism, and improves management efficiency.

公司持续以制度规范风险内控管理,发布《中钢洛耐全面风险与内部控制管理制度》等系列风险内控管理制度,不断完善制度体系,为相关工作开展提供有力保障。设置风险内控专职部门,负责公司风险管理体系策划、内控体系建设与运行,推进工作融合、完善风险控制措施,以及对外业务授权和子公司内控指导监督。

The company continuously standardizes the risk and internal control management with systems, and has issued a series of risk and internal control management systems such as the "Sinosteel Luonai Comprehensive Risk and Internal Control Management System", constantly improving the system framework, providing strong guarantee for the implementation of relevant work. A full-time department for risk and internal control has been set up, which is responsible for the planning of the company's risk management system, the construction and operation of the internal control system, promoting the integration of work, improving risk control measures, as well as the external business authorization and the internal control guidance and supervision of subsidiaries.



组织协调风险识别、处置、防控工作,发布应急预案,建立预警监督机制,定期完善风险监控指标,不定期发布风险专题提示,要求各单位落实管控措施,守住风险底线。定期发布企业环境、社会及治理(ESG)报告,各部门各单位通力合作,开展企业自身ESG尽职调查,全面审视自身在环境、社会及治理方面的表现,发现优势与不足,从而将ESG目标融入战略任务,实现长期可持续发展。

It organizes and coordinates the work of risk identification, handling, prevention and control, issues emergency response plans, establishes an early warning and supervision mechanism, regularly improves the risk monitoring indicators, and issues special risk prompts irregularly, requiring each unit to implement control measures and hold the bottom line of risks. It regularly releases the Enterprise Environmental, Social and Governance (ESG) report. All departments and units cooperate fully to carry out the ESG due diligence investigation of the enterprise itself, comprehensively review their own performance in environmental, social and governance aspects, identify the advantages and disadvantages, so as to integrate the ESG objectives into the strategic tasks and achieve long-term sustainable development.

## 低碳转型

### 以“绿”永续, 提升含“绿”量

Low-carbon transformation:  
advancing sustainable green development



2024年,公司坚持以习近平生态文明思想为指导,全面落实全国生态环境保护大会精神,完整准确全面贯彻新发展理念,坚持生态优先、绿色低碳发展,遵守国家有关生态环境保护法律法规要求,实行污染物减排与环境治理并举。报告期内投入环保资金**2850.77**万元,缴纳环保税共计**38.99**万元。

In 2024, guided by Xi Jinping Thought on Ecological Civilization, We fully implemented the spirit of the National Conference on Ecological and Environmental Protection, thoroughly, accurately and comprehensively applied the new development philosophy, adhered to the principles of giving priority to ecological protection and pursuing green and low-carbon development, abided by the requirements of national laws and regulations on ecological and environmental protection, and simultaneously carried out both pollutant emission reduction and environmental governance. During the reporting period, we invested CNY 28,507.7 million in environmental protection funds and paid a total of CNY 389,900 in environmental protection taxes.



## 健全完善管理制度 提升规范化水平

### Improving the management system and enhancing the level of standardization

公司高度重视节能环保工作,不断完善相关制度,2024年调整了能源环保管理委员会,制定发布了《能源管理办法》《固体废物管理办法》《危险废弃物管理办法》《环保事件问责管理办法》等制度,加强了对能源和固危废的管理,进一步提升环保管理规范化水平。

We attach great importance to energy conservation and environmental protection and continuously improve the relevant systems. In 2024, We adjusted the Energy and Environmental Protection Management Committee and formulated and issued systems such as the Measures for Energy Management, the Measures for Solid Waste Management, the Measures for Hazardous Waste Management, and the Measures for Accountability Management of Environmental Protection Incidents. These measures have strengthened the management of energy, solid waste, and hazardous waste, and further enhanced the standardization level of environmental protection management.



公司及所属子公司定期对厂区生活污水管道、隔油池、沉淀池、总排口进行清理和维护,规范排污口设置。2024年,耐研滨河更新了污水处理设备,提升了污水处理能力和效果,处理后的废水用于绿化,可实现废水零排放。报告期内,公司万元产值用新水量(可比价)为**1.51**吨/万元,循环使用的水量为**465.17**万吨。

The company and its subsidiaries regularly clean and maintain the domestic sewage pipelines, oil separation tanks, sedimentation tanks and general discharge outlets within the factory areas, and standardize the setting of sewage discharge outlets. In 2024, Sinosteel Ningxia LIRR Binhe New Material Co., Ltd. updated the sewage treatment equipment, improving the sewage treatment capacity and effect. The treated wastewater is used for greening purposes, achieving zero wastewater discharge. During the reporting period, the new water consumption per CNY 10,000 output value (at comparable prices) of the company was 1.51 tons per CNY 10,000, and the recycled water consumption was 4.6517 million tons.

公司制定了《黄河流域生态环境保护规划》,并对年度废气减排目标进行了分解、签订了目标责任书,建立了《环保事件问责管理办法》、环保十条禁令等文件。采取自查自纠34项问题并整改、排查环保设施风险、开展环保升级改造、升级4套门禁系统等措施减少废气排放。2024年实际二氧化硫排放总量**25.24**吨,氮氧化物排放总量**44.35**吨,完成年度减排目标。

We formulated the "Ecological Environment Protection Plan for the Yellow River Basin", decomposed the annual waste gas emission reduction targets, and signed target responsibility contract. We also established documents such as the "Measures for Accountability Management of Environmental Protection Incidents" and the Ten Prohibitions on Environmental Protection. We taken a series of measures to reduce waste gas emissions, including the self-inspection and rectification of 34 the problems, the investigation of environmental protection facilities risks, the Promotion and transformation of environmental protection, and the upgrading of 4 access control systems. In 2024, the actual total emissions of sulfur dioxide were 25.24 tons, and the total emissions of nitrogen oxides were 44.35 tons, achieving the annual emission reduction targets.

2024年发布《固体废物管理办法》和《危险废弃物管理办法》,进一步规范了固废和危废的管理。一般工业固废自行或交其他单位回用,危废交有资质第三方处置,开展固废减量等工作,助力“无废城市”“无废集团”建设,危废合规暂存处置率**100%**,配合土壤和地下水调查采样。固体废物综合利用率**100%**,2024年公司产生危废**22.20**吨,转移处置**22.88**吨(含去年库存**0.68**吨),合规暂存处置率**100%**。子公司被洛阳市工信局评为洛阳市第二批“无废工厂”。

In 2024, the Measures for Solid Waste Management and the Measures for Hazardous Waste Management were issued, further standardizing the management of solid waste and hazardous waste. General industrial solid waste is either recycled by the company itself or handed over to other units for recycling, while hazardous waste is entrusted to qualified third-party disposal companies. Work such as solid waste reduction has been carried out to contribute to the construction of a "waste-free city" and a "waste-free group". The compliance rate of temporary storage and disposal of hazardous waste is 100%. We also cooperates for soil and groundwater investigation and sampling. The comprehensive utilization rate of solid waste is 100%. In 2024, we generated 22.20 tons of hazardous waste, and 22.88 tons (including 0.68 tons of inventory from the previous year) were transferred for disposal, with a compliance rate of temporary storage and disposal reaching 100%. Our subcompany was rated as the second batch of "Waste-free Factory" in Luoyang.

## 坚持绿色发展理念 降低能源消耗

### Upholding green development principles and reducing energy consumption

公司主要涉及能源为电、天然气,主要涉及资源为水资源、原辅材料。2024年新建了约3兆瓦分布式光伏发电,报告期内,公司能源消费分别为电力10,593.13万千瓦时;天然气3,190.99万立方米。公司主要通过建设新能源项目、更新重点用能设备、优化烧成工艺、通过优化配方降低烧成温度、窑炉余热利用、采购节能电机等措施降低单位产品能耗,节约电力和天然气等能源;通过节水设备使用、生产工艺优化、节约生活用水等措施,降低水资源的消耗及对水环境的影响;通过提高产品合格率、资源回收利用和减少原料撒漏等措施减少原辅材料的消耗。制定包装制度,严禁浪费角纸、垫纸、纸板等包装辅材;精确计算耗材用量后裁剪,回收余料用于其他产品,包装材料边角料也回收利用。在保证产品质量的前提下,减小包装材料厚度。根据产品规格和数量提前规划,充分利用托盘或木箱有效空间,减少使用量。对需求量大的产品,专项定制包装纸片规格和厚度,避免产生废角料。统一收集破碎托盘,用于盛放原料、不合格品或其他自用产品;统一收集废弃吨包装袋,用于盛放日常垃圾、废弃物或周转物料;回收利用原料附带的质量较好的木托盘。报告期内,制成品所用包装材料总量约9000吨,回收包装材料约占3%。





In the company, the main energy sources are electricity and natural gas, and the main resources it involves are water resources, raw and auxiliary materials. In 2024, a distributed photovoltaic power generation project of approximately 3 MW was newly built. During the reporting period, the energy consumption was 105.9313 million kWh of electricity and 31.9099 million cubic meters of natural gas. The company mainly reduces the energy consumption per unit of products and saves electricity and natural gas energy sources through measures such as building new energy projects, updating key energy-consuming equipment, optimizing the firing process, reducing the firing temperature by optimizing the formulation, utilizing the waste heat of kilns, and purchasing energy-saving motors. The company reduces the consumption of water resources and the impact on the water environment through measures such as using water-saving equipment, optimizing the production process, and saving domestic water. The company also reduces the consumption of raw and auxiliary materials through measures such as improving the product qualification rate, recycling resources, and reducing raw material spills. The company has formulated a packaging system, strictly prohibiting the waste of packaging auxiliary materials such as corner papers, cushion papers, and cardboards. The materials are cut after accurately calculating the consumption, and the remaining materials are recycled for other products. The cuttings of packaging materials are also recycled. On the premise of ensuring product quality, the thickness of packaging materials is reduced. According to product specifications and quantities, advance planning is carried out to make full use of the effective space of pallets or wooden boxes and reduce their usage. For products of high demand, the specifications and thickness of packaging paper are specially customized to avoid generating scrap corners. Broken pallets are uniformly collected to hold raw materials, nonconforming products, or other self-used products. Discarded ton bags are uniformly collected to hold daily garbage, waste, or turnover materials. The relatively good wooden pallets attached to raw materials are recycled. During the reporting period, the total amount of packaging materials for finished products was approximately 9,000 tons, and the recycled packaging materials accounted for approximately 3%.

## 加大厂区绿化力度 保护生物多样性

### Increasing the factory greening and protecting biodiversity

公司积极践行国家生态保护战略,聚焦生物多样性保护及黄河流域生态治理目标,大力推进厂区绿化工作。2024年,新种植**1450平方米**麦冬,新增绿地**6512平方米**,栽种乔木约**70棵**,选用本地适生树种,为昆虫、鸟类等生物提供栖息地,助力构建“城市工业生态微系统”,推动生物多样性“就地保护”,以实际行动履行企业环保责任。



The company actively implements the national ecological protection strategy, focuses on the goals of biodiversity conservation and ecological governance in the Yellow River Basin, and vigorously promotes greening in the factory area. In 2024, 1,450 square meters of Ophiopogon japonicus were newly planted and the green area increased by 6,512 square meters, and about 70 arbors were planted. Native tree species suitable for growth were selected to provide habitats for insects, birds and other organisms. This helps to build an "urban industrial ecological microsystem", promotes the "in-situ conservation" of biodiversity, and fulfills the enterprise's environmental protection responsibilities with practical actions.

## 应对气候变化 助力“双碳”目标

### Addressing climate change and supporting the "Dual-Carbon Goals"

公司坚持把节约能源资源放在首位,加大节能减碳项目实施力度,推动能耗双控转向碳排放双控,从源头减少二氧化碳排放。公司温室气体排放主要为天然气燃烧产生的直接二氧化碳排放、净购入的电力消费产生的间接二氧化碳排放。

The company persists in prioritizing energy and resource conservation, intensifies the implementation of energy-saving and carbon reduction projects, promotes the shift from dual control of energy consumption to dual control of carbon emissions, and reduces carbon dioxide emissions at the source. The company's greenhouse gas emissions mainly include direct carbon dioxide emissions generated from the combustion of natural gas and indirect carbon dioxide emissions resulted from the net purchased electricity consumption.

2024年,公司温室气体排放量共计为**127627.29吨**。

In 2024, the total greenhouse gas emissions amounted to **127,627.29 tons**.

公司积极响应“碳达峰碳中和”政策,落实“双碳”及新能源政策,开展产品碳足迹核算,推进新能源建设、窑炉余热利用改造,加装太阳能路灯,更换新型节能变压器、空压机和电机并维护,实现节能降碳,减少化石能源消耗。报告期内,公司建成**10兆瓦**分布式光伏并网发电,全年光伏发电**680万Kwh**,降低用电成本约**118万元**,持续优化能源消费结构。

The company actively responds to the policies of "carbon emission peaking and carbon neutrality", implements the "dual carbon" and new energy policies, conducts product carbon footprint accounting, promotes the construction of new energy sources, transforms kilns for the utilization of waste heat, installs solar street lamps, replaces and maintains new energy-saving transformers, air compressors and motors, so as to achieve energy conservation and carbon reduction and reduce the consumption of fossil energy. During the reporting period, the company built a 10-megawatt distributed photovoltaic grid-connected power generation project, and the annual photovoltaic power generation reached 6.8 million Kwh, reducing the electricity cost by approximately CNY1.18 million and continuously optimizing the energy consumption structure.

公司实施绿色采购,推动落后电机更新,报告期内,淘汰18台落后制冷设备,更新45台落后电机;在项目建设和设备采购中,推广使用一级或二级能效设备,提升节能水平。对干燥窑进行热风循环改造,增强均温性与保温性能,大幅降低干燥用电量;改造利用隧道窑余热,用于办公楼取暖和车间工人洗澡,提升用能效率。

The company implements green procurement and promotes the renewal of backward motors. During the reporting period, 18 sets of backward refrigeration equipment were phased out, and 45 sets of backward motors were updated. In project construction and equipment procurement, the company promotes the application of first-level or second-level energy efficiency equipment to improve the energy-saving level. The hot air circulation renovation was carried out on the drying kilns to enhance the temperature uniformity and heat preservation performance, significantly reducing the electricity consumption for drying. The waste heat from the tunnel kiln was renovated and utilized for heating the office building and providing hot water for workers in the workshop, thus improving energy utilization efficiency.

公司以“碳达峰、碳中和”为契机,在追求自身绿色发展的同时,大力研发节能环保新产品,开拓新市场,为高温领域节能减排、降本增效和技术进步贡献力量。在科研项目立项阶段,成立包含环保专家在内的项目评审组,立项建议书中设立了环境评价章节,对可能使用的有毒有害原料、高能耗设备,以及生产和使用后可能带来的环境危害进行全面而深入的评估,从源头上降低环境风险。

Taking the opportunities of "carbon emission peaking and carbon neutrality", while pursuing its own green development, the company vigorously researches and develops new energy-saving and environmental protection products, and explores new markets, contributing to energy conservation, emission reduction, cost reduction, efficiency improvement and technological progress in the high-temperature field. During the initiation stage of scientific research projects, a project evaluation team including environmental protection experts is established, and an environmental assessment chapter is set up in the project initiation proposal to conduct a comprehensive and in-depth assessment of potentially toxic and hazardous raw materials, high-energy-consuming equipment, and the possible environmental hazards brought about after production and use, thereby reducing environmental risks from the source.

公司成功研发多项关键产品与技术:电熔铸铬刚玉产品是我国玻璃固化技术处理核工业高放废液的关键炉衬材料,已完成中试,在首套玻璃固化陶瓷电熔炉试验炉上使用超过一年,有力支撑关键工艺与配方研制;多孔陶瓷烧嘴用于燃气轮机,使燃料充分燃烧,热量场分布均匀,降低能量损耗与氮氧化物排放;低成本高性能气凝胶材料热导率极低,可广泛应用于绿色建筑,减少热能散失;耐火材料不定形化与免高温烧成技术,借助高效结合剂等工艺,减少制作工序的机械损毁与热损耗,保证性能的同时减少烧成环节,节约能源。

The company has successfully developed a number of key products and technologies. The electrofused cast chrome corundum product is a crucial furnace lining material for the treatment of high-level radioactive liquid waste in the nuclear industry through the vitrification technology in China. It has completed the pilot test and has been used on the first set of the vitrification ceramic electric melting test furnace for more than a year, strongly supporting the development of key processes and formulations. The porous ceramic burner, used in gas turbines, enables the fuel to burn completely, ensuring a uniform heat distribution, thus reducing energy loss and nitrogen oxide emissions. The low-cost and high-performance aerogel material has an extremely low thermal conductivity and can be widely applied in green buildings to reduce heat loss. The unshaping and high-temperature free firing technology of refractories, with the help of high-efficiency binders and other processes, reduces the mechanical damage and thermal loss during manufacturing, which reduces the firing process and saves energy while ensuring the performance.



光伏发电

公司践行“双碳”发展战略,根据公司实际,设定应对气候变化目标为万元产值二氧化碳排放量0.61吨/万元,实际温室气体排放强度为万元产值二氧化碳排放(可比价)为0.55吨二氧化碳当量/万元。

The company implements the "dual carbon" development strategy. Based on its actual situation, the company has set the target for addressing climate change as 0.61 tons carbon dioxide emissions per CNY 10,000 output value and the actual greenhouse gas emission intensity is 0.55 tons carbon dioxide equivalent per CNY 10,000 output value (at comparable prices).

公司针对钢铁行业低碳绿色的发展需求,基于高炉富氢冶炼、全氢冶炼和氢基竖炉冶炼等“以氢代碳”的绿色冶炼新技术、新装置,开展了相关耐火材料的合理配置和长寿化研究,研究了耐火材料侵蚀机理及积碳行为,为低碳冶金高温装置耐火材料的科学配置、新材料研发和炉衬长寿化提供理论基础。

To satisfy the low-carbon and green development needs of the steel industry, the company has carried out research on the rational allocation and long-life design of relevant refractory materials based on new green smelting technologies and devices such as hydrogen-enriched blast furnace smelting, all-hydrogen smelting, and hydrogen-based shaft furnace smelting that feature the substitution of hydrogen for carbon. The corrosion mechanism of refractory materials and the carbon deposition behavior were studied, providing a theoretical basis for the scientific configuration of refractory materials for high-temperature devices in low-carbon metallurgy, the research and development of new materials, and the long service life of furnace linings.

公司与欧冶工业品合作,牵头制定了《耐火材料产品种类规则(PCR)》,已在钢铁全产业链EPD平台发布。此次制定的PCR文件是全球首个针对耐火材料产品的EPD(环境产品声明)分类规则,填补了国际标准空白,为行业提供了科学、规范的环境影响评价框架。将通过数据透明化、评价标准化和行动协同化,推动耐火材料行业从“高能耗、高排放”传统模式向绿色低碳高质量模式转型,为我国实现“双碳”目标、参与全球气候治理提供实质性支撑。

Cooperated with Obei, the company took the lead in formulating the "Product Category Rules (PCR) for Refractory Materials", which has been released on the EPD platform of the entire steel industry chain. The PCR document is the world's first EPD (Environmental Product Declaration) classification rule for refractory materials products, filling the gap in international standards and providing a scientific and standardized environmental impact assessment framework for the industry. Through data transparency, evaluation standardization, and coordinated actions, it will promote the transformation of the refractory materials industry from the traditional mode of "high energy consumption and high emissions" to a green, low-carbon and high-quality mode, providing substantial support for China to achieve the "dual carbon" goals and participate in global climate governance.

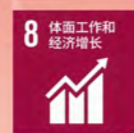

The company earnestly implement the important expositions of General Secretary Xi Jinping on rural revitalization. In accordance with relevant arrangements, we dispatched the fifth resident village first secretary to Jinggou Community in Ruyang County, the designated poverty alleviation area, to carry out resident village assistance work and contribute to rural revitalization. Through methods such as purchasing festival benefits, employee purchases, and employee-assisted sales, we helped consume more than CNY 182,300 products produced by rural households. During the reporting period, the company strictly fulfilled information disclosure obligations, ensuring that the information disclosure work is true, accurate, complete and timely. At the same time, it publicly disclosed information to all investors, ensuring that all shareholders have an equal opportunity to obtain information. The company also attaches great importance to the reasonable investment returns of investors and formulates dividend plan in accordance with the requirements of the dividend policy to safeguard the legitimate rights of shareholders. The company safeguards the rights of creditors by means such as signing contracts and regular payment, and communicates and maintains information contact with creditors in a timely manner through mutual visits and exchanges, which has created an environment of win-win cooperation and common development.

We adhere to the system of the workers' congress, hold the workers' congress and the trade union congress every year, and sign the "Collective Contract" and the "Special Collective Contract for the Protection of Female Employees' Special Rights and Interests". We persist in carrying out the activity of "Caring for You, Me, Him/Her and Bringing Warmth to Thousands of Families" and the assistance work for employees in difficulties. During the Spring Festival in 2024, we paid visits and extended condolences to 56 retired senior employees, front-line employees in difficulties, model workers at the provincial level and above who are still in service, and employees at overseas project sites during the Spring Festival. A total of CNY 101,800 in warm assistance funds and supplies were distributed. In order to solve the problem of the difficulty for employees' children to enroll in nearby schools, we coordinated and arranged for 39 employees' children to enter nearby kindergartens and schools. In 2024, a total of 2,182 employees in our company participated in the mutual assistance insurance in Luoyang, and the trade union of the company provided a special subsidy of CNY 43,600.

We have established a comprehensive human resources incentive system and constructed a dual-channel employee career development and promotion system. And established a standardized and unified post system management system that meets the "flat and efficient" management requirements of Sinosteel Luonai, clearly defined various management requirements for posts, and promoted the institutionalization, standardization, and scientification of management. A vertical post-level promotion incentive mechanism and a classified salary system adapted to different types of employees have been established. Guided by capabilities and performance, the accuracy of salary incentives has been enhanced.

When new employees join us, they will receive three-level safety education and practical training to help them get to know the company. For on-the-job employees, targeted job skill training is carried out according to their positions and levels. Training for middle-level cadres and general management positions is organized to enhance the capabilities, professional levels, and comprehensive qualities, strengthening the company's core competitiveness. We also strengthen the training and education on scientific and technological ethics for scientific research and development personnel. Through symposiums, academic exchange meetings and other means, we educate and guide scientific and technological personnel to abide by research ethics norms and establish correct values. Relying on the Scientist Spirit Education Base, we conduct a variety of activities of inheritance, promotion, publicity and popular science of the scientist spirit, helping the company to create a strong atmosphere of respecting knowledge, advocating innovation, valuing talents and loving science.

2024年,公司在员工培训方面投入的资金总额为**49.33**万元。2024全年开展了中央企业干部研学班、能源环保管理能力提升等**142**项培训,覆盖员工**2574**人。线下培训**19580**人次,完成**97769.5**总学时;线上培训**14720**人次,完成**70537**总学时,累计培训**34300**人次,完成**168306.5**总学时。

In 2024, we invested a total of CNY 49,300 in employee training. In 2024, a total of 142 training programs were carried out, including the study class for cadres of central enterprises and the improvement of energy and environmental protection management capabilities. These training programs covered 2,574 employees. There were 19,580 person-time of offline training, with a total of 97,769.5 class hours completed; and 14,720 person-time of online training, with a total of 70,537 class hours completed. In total, there were 34,300 person-time of training, and a total of 168,306.5 class hours were completed.

## 完善采购模式 打造绿色供应链

### Refining procurement models to build a sustainable supply chain

公司已形成成熟的采购模式,配合生产模式运行,根据生产计划、结合安全库存管理,采购部门根据原料产品特性、供货周期以及市场价格波动等因素,决定采购行为。坚持公平公正公开,制定合格供应商管理制度,通过招标、询价、竞争性谈判等方式,建立了由多部门共同参与、相互制衡的采购控制体系,保证中小企业和大企业拥有同等的信息获取渠道。公司采购部门负责对供应商进行管理和优化,规范组织确定合格供应商名录;根据公司发展规划、年度生产经营计划、物资消耗定额、合理库存和使用单位用料计划等内外部因素制定物资采购计划,并会同采购招标部门、生产单位、财务部门、生产管理部门,按照公司相关管理制度在合格的供应商范围内通过公开招标、比价方式确定供应商。采购商品进入公司后,由质量管理部门与生产单位共同进行外观检查,并由技术部门进行性能检测;仓储管理人员对到达公司的原料、燃料数量、包装进行检查核实。

We have developed a mature procurement model that operates in tandem with the production model. Based on the production plan and combined with safety stock management, the procurement department determines procurement actions considering factors such as the characteristics of raw material products, supply cycle, and market price fluctuations. Adhering to the principles of fairness, impartiality, and openness, we have formulated a management system for qualified suppliers. Through methods such as bidding, inquiry, and competitive negotiation, we have established a procurement control system with the joint participation and mutual checks and balances of multiple departments, ensuring that small and medium-sized enterprises have the same access to information as large enterprises. Our procurement department is responsible for managing and optimizing suppliers and

standardizing the organization to determine the list of qualified suppliers. It formulates the material procurement plan based on internal and external factors such as development plan, annual production and operation plan, material consumption quota, reasonable inventory, and the material usage plan of the using units. In conjunction with the procurement bidding department, production units, finance department, production management department, and other departments, we determine suppliers through public bidding and price comparison within the scope of qualified suppliers in accordance with the relevant management systems. After the purchased goods enter the company, the quality management department and the production unit jointly conduct appearance inspections, and the technical department conducts performance tests. Warehouse management personnel check and verify the quantity and packaging of the raw materials and fuels arriving at the company.

构建“准入、审核、评估”供应商管理体系,公司依客户需求筛选新进供应商,提出质量、环保等资质要求(如ISO 14001、ISO 9001等),分类管理不同类型供应商,要求提供特定许可文件。对新进供应商填“供方调查评价表”,经分管领导和采购中心审核生效;定期对稳定合作供应商开展现场质量审核,跟踪验证整改效果。评估标准含定量绩效、采购员评价和用户单位评价,结合综合评价体系给供应商年度综合评分。2024年,公司ESG培训覆盖供应商数量为6家,合格供应商数量为435家,预备级供应商13家,供应商总数为571个。

We have constructed a supplier management system of "access, review, and evaluation". In line with customer requirements, the company screens new suppliers, puts forward qualification requirements regarding quality, environmental protection, etc. (such as ISO 14001, and ISO 9001, manages different types of suppliers by classification, and requires them to provide specific permit documents. New suppliers are required to fill in the "Supplier Investigation and Evaluation Form", which becomes effective after being reviewed by the responsible leaders and the procurement center. Regular on-site quality audits are carried out for suppliers with stable cooperation, and the rectification effects are tracked and verified. The evaluation criteria include quantitative performance, purchaser evaluation, and evaluation by user units. An annual comprehensive score is given to suppliers based on a comprehensive evaluation system. In 2024, the number of suppliers covered by the ESG training was 6. The number of qualified suppliers was 435, the number of pre-qualified suppliers was 13, and the total number of suppliers was 571.

We deeply implement the national concept of green development, fulfill the social responsibilities of state-owned enterprises, construct a green, low-carbon and sustainable procurement supply chain system for refractory materials, and promote the high-quality development. The management of the green procurement chain is carried out in accordance with the principles of "green leadership, full-chain control, collaborative co-construction, continuous optimization-publicity and promotion". A green procurement leading group has been established. The procurement system has been revised to incorporate green procurement requirements. A green procurement catalog has been formulated, with increased capital investment. A green supplier evaluation system has been built, and the environmental protection clauses in procurement contracts have been improved. Green training for suppliers is carried out to assist their green transformation. An environmental information sharing platform has been set up, green performance evaluation has been implemented, and problems are rectified in a timely manner. An e-procurement system has been promoted, and big data analysis is used to assist decision-making. Publicity activities are carried out to enhance employees' awareness, summarize and promote experience, and set up benchmark demonstrations.

Our wholly-owned subsidiary has also obtained the GJB9001C-2017 Military Standard Quality Management System Certification, and some instrument and equipment products have passed the CE Certification.

We attach great importance to system construction. We have formulated supporting documents and management systems such as the "Quality, Environment, Energy, Occupational Health and Safety Management Manual", and cultivated high-quality quality-related talents. Every year, we undergo supervision and review by third-party certification bodies to improve management efficiency. We have carried out a series of quality improvement activities such as 64 person-time of quality-themed training, and more than 1,280 people participated in the quality-answering competition of the China Quality Association online. We have held QC activities for many times to encourage employees to participate in quality improvement. In 2024, the product qualification rate was 95.71%, and three QC activities won the first prize of the excellent quality management team in Luoyang.

It creates value for customers through lean services, promotes project or regional general contracting, and expands the service scope. Adhering to the customer-first principle and providing lean services, the company offers equal cooperation opportunities to both small and medium-sized enterprise customers and large customers. It integrates internal and external advantageous resources, establishes stable and efficient sales channels, strengthens on-site technical services and management, optimizes product quality, and wins the trust of customers.

## 践行“一带一路”海外项目快速发展

### Advancing the belt and road initiative for rapid overseas expansion

公司积极响应全球发展倡议,深度融入国家“一带一路”政策,秉持合作共赢理念,大力推进海外履责实践。以“一带一路”为市场主干线、以印度、中东、俄罗斯等活跃市场为重点,以传统基建产品为基础,以耗材为持续增长点,以直接服务终端客户为最终目标,以集团国际平台和国内外设计总包公司为引领,全面开发国际市场,海外项目发展呈现出多元化和快速发展的趋势。公司始终在前期优质合作的基础上,紧盯印尼项目,成功签订了中伟高冰镍冶炼富氧侧吹炉、回转窑约6000万元人民币项目、力勤KPS二期回转窑约4700万元人民币项目、力勤印尼电解铝约4400万元人民币项目。首次向日本成批次供应焦炉维修预制件,向欧洲客户提供焦炉炉门砖,供货沙特防腐行业用碳化硅砖,供货达涅利设计DRI管道用耐磨瓷块。公司紧抓时机,在俄罗斯市场上取得重大突破,首次签订俄罗斯市场玻璃窑用硅砖订单、炼铜竖炉碳化硅订单、二段炉刚玉砖订单,齿科设备市场也增长迅速。

We actively respond to the Global Development Initiative and deeply integrate into the national "Belt and Road" policy. Upholding the concept of win-win cooperation, we vigorously promote overseas responsibility - fulfillment practices. Taking the "Belt and Road" as the main market line, focusing on active markets such as India, the Middle East, and Russia, basing on traditional infrastructure products, regarding consumables as a continuous growth point, aiming at directly serving end - customers, and being led by the group's international platform and domestic and foreign design general contracting companies, we comprehensively develop the international market. The development of overseas projects shows a trend of diversification and rapid growth. Based on previous high - quality cooperation, we have been closely following the Indonesian projects and successfully signed projects worth approximately CNY 60 million for the oxygen - enriched side - blown furnace and rotary kiln of Zhongwei High - Ice Nickel Smelting, approximately CNY 47 million for the rotary kiln of Liqin KPS Phase II, and approximately CNY 44 million for Liqin Indonesia's electrolytic aluminum. For the first time, it supplied coke oven repair prefabricated parts to Japan in batches, provided coke oven door bricks to European customers, supplied silicon carbide bricks for the anti - corrosion industry in Saudi Arabia, and supplied wear - resistant ceramic blocks for DRI pipelines designed by Danieli. Seizing the opportunity, the company has made significant breakthroughs in the Russian market: it signed orders for silica bricks for glass furnaces, silicon carbide for copper - smelting shaft furnaces, and corundum bricks for secondary furnaces in the Russian market for the first time. The dental equipment market has also grown rapidly.

2024年,公司高效完成印尼16项、阿尔及利亚4项、马来西亚1项施工项目,目前印尼仍有17个在建项目。海外业务呈“以点带面”高速拓展趋势,彰显出中钢洛耐产品与服务的卓越品质,展现了中钢洛耐投身国际合作的强大动力和实干精神。在“一带一路”沿线的阿尔及利亚项目,当地员工雇佣比例最高达60%,有力带动当地就业,增加居民收入,促进了当地经济发展。

In 2024, we efficiently completed 16 construction projects in Indonesia, 4 in Algeria, and 1 in Malaysia. There are still 17 ongoing projects in Indonesia. The overseas business is expanding at a high speed in a "radiating from point to area" manner, demonstrating the outstanding quality of Sinosteel Luonai's products and services, as well as the strong impetus and practical spirit of engaging in international cooperation in the new era. In the Algerian projects along the "Belt and Road", the employment proportion of local employees reached up to 60%, which effectively promoted local employment, increased residents' income, and contributed to local economic development.

## 完善安全管理制度 促进公司持续发展

### Strengthening safety management systems to ensure sustainable growth

公司设立安全管理专责部门,明确安全体系、安全监督、防灾保卫三个模块职责。成立安全生产委员会,董事长、总经理任安委会主任,分管安全副总经理任安委会副主任。

We have established a dedicated safety management department, clearly defining the responsibilities of three modules: the safety system, safety supervision, and disaster prevention and security. We have also set up a Work Safety Committee, with the chairman and general manager serving as the directors of the committee, and the deputy general manager in charge of safety serving as the deputy director.

按照生产经营业务范围,组织对公司涉及的职业健康安全法律、法规进行识别,识别确定公司主要涉及的法律、法规和标准规范196部,建立公司《职业健康安全法律、法规和标准清单》,并组织各单位学习相应的法律、法规,及时传达给相关人员,确保相关方要求及时落实。组织制(修)订职业健康安全规章制度及标准、预案26项,并对制度进行宣贯、解读,确保各项制度有效落实。

In line with the scope of production and business operations, we organize the identification of occupational health and safety laws and regulations relevant to its operations. A total of 196 main laws, regulations, and standard specifications have been identified, and the company has established the "List of Occupational Health and Safety Laws, Regulations, and Standards". Moreover, it organizes each unit to study the corresponding laws and regulations and promptly conveys them to relevant personnel to ensure the timely implementation of the requirements of relevant parties. We have organized the formulation (revision) of 26 occupational health and safety rules, regulations, standards, and emergency plans. It also publicizes and interprets these systems to ensure their effective implementation.

We have carried out special governance on standardized operation for work safety. We have organized the assessment and revision of 229 safety operation procedures. To enhance employees' safety awareness, we have organized various types of training, such as training and certification for safety management personnel and the promotion of the Law on Prevention and Control of Occupational Diseases. The company's main responsible people, work safety management personnel, occupational health management personnel, special operation personnel, and special equipment operators have all obtained corresponding management qualification certificates and operation qualification certificates in accordance with the law. The certificate holding rate at all levels is **100%**.

公司根据国家关于安全生产费用的相关规定,制定《安全生产费用使用管理办法》,依法提取和使用安全生产费用,2024年安全生产投入**1073.73万元**。以安全生产月为契机,开展安全承诺宣誓、安全签字活动;举办“安康杯”安全生产知识竞赛,广泛普及安全生产知识,大力弘扬安全文化。公司2024年开展各类培训及知识学习和竞赛活动**10**次,培训受众**3736**人次,培训覆盖率**100%**。

In accordance with relevant national regulations on work safety expenses, we have formulated the "Administrative Measures for the Use of Work Safety Expenses", and use work safety expenses in accordance with the law. In 2024, the investment in work safety was CNY **10.7373 million**. Taking the Work Safety Month as an opportunity, we carried out safety commitment oaths and safety signature activities, and held the "Ankang Cup" Work Safety Knowledge Competition to widely popularize work safety knowledge and vigorously promote safety culture. In 2024, the company carried out **10** training sessions, knowledge learning activities, and competitions, covering **3,736** people, with a training coverage rate of **100%**.

公司制定发布《危险源辨识、风险评价及风险分级管控管理办法》,组织开展危险源辨识、风险分析与风险分级管控,制定针对性的风险控制措施,有效防范化解各类安全风险;公司制定发布《安全生产事故隐患排查治理管理办法》等文件,建立事故隐患排查机制,深入推进事故隐患排查整治。2024年,应急管理部门、集团公司及公司共排查治理事故隐患**607**项,隐患整改率**100%**。

We have the "Administrative Measures for Hazard Identification, Risk Assessment and Risk Classification Control", organized the identification of hazards, risk analysis and risk classification control, and formulated targeted risk control measures to effectively prevent and defuse various safety risks. We have also issued documents such as the "Administrative Measures for the Investigation and Rectification of Work Safety Accident Hidden Dangers", established an accident hidden danger investigation mechanism, and deeply promoted the investigation and rectification of accident hidden dangers. In 2024, the emergency management department, the parent company and the company jointly investigated and rectified 607 accident hidden dangers, with a hidden danger rectification rate of **100%**.

We have revised the "Production Safety Accident Emergency Plan" and formulated and issued the "Administrative Measures for Production Safety Accident Emergency Plan". We have carried out emergency resource surveys and accident risk assessments, established and improved the framework of the emergency management system, provided emergency knowledge training such as fire protection for administrative office staff at the company's headquarters, and organized 2 company-level accident emergency plan drills to enhance employees' safety emergency capabilities and awareness. Each unit has carried out more than **50** emergency drills at various levels and of various types, with more than **2,584** people participating in the drills. Through actual emergency actions, the safety concept of "everyone emphasizes safety and everyone can respond to emergencies" has been implemented, creating a safety atmosphere of "everyone emphasizes safety and everyone knows safety" within the company.

加强职业健康管理。公司制定《职工劳动防护用品管理办法》,为员工配备劳动防护用品,指导员工正确使用并定期检查劳动防护用品使用情况,使员工在劳动过程中免遭或者减轻事故伤害和职业病危害。公司通过ISO45001职业健康安全管理体系认证。扩大员工体检覆盖率,2024年公司接触职业病危害的员工均参加了职业健康检查,体检覆盖率**100%**。

We strengthen occupational health management. We have formulated the "Administrative Measures for Employees' Labor Protection Articles", providing employees with labor protection articles, guiding employees on their correct use, and regularly inspecting the usage of labor protection articles, so as to protect employees from accident injuries and occupational disease hazards during the labor process. We have passed the ISO45001 Occupational Health and Safety Management System Certification. The company has expanded the coverage of employee physical examinations. In 2024, all employees exposed to occupational disease hazards in the company participated in occupational health examinations, with a physical examination coverage rate of **100%**.
